India's G20 Presidency



Prime Minister Narendra Modi visited Indonesia from November 14-16 to attend the 17th G20 Summit at the invitation of the President of Indonesia, H.E. Mr. Joko Widodo. At the closing session of the Summit, President Widodo symbolically handed over the G20 Presidency to Prime Minister Modi as India assumes the G20 Presidency from 1 December 2022.

Earlier, India's G20 Presidency under the theme "One earth, one family, one future", logo and website <https://www.g20.org/en/> were unveiled by PM Modi on 8 November 2022. During India's Presidency, India, Indonesia and Brazil would form the troika. This would be the first time when the troika would consist of three developing countries and emerging economies, providing them a greater voice.

During the unveiling function, the Prime Minister underlined that lotus in the logo represents hope to overcome the circumstances and its seven petals represent the seven continents in the world. It represents harmony while respecting diversity. India understands the Global South's developmental aspirations and seeks to advance truly one world and one future.

India assumes Chair of Global Partnership on Artificial Intelligence



Close on the heels of assuming the presidency of G20, on 21 November, India took over the chair of the Global Partnership on Artificial Intelligence (GPAI), an international initiative to support responsible and human-centric development and use of Artificial Intelligence (AI). AI is expected to add US\$967 billion to Indian economy by 2035 and US\$ 450-500 billion to India's GDP by 2025, accounting for 10% of the country's USD 5 trillion GDP target.

GPAI is a congregation of 25 member countries, including the US, the UK, EU, Australia, Canada, France, Germany, Italy, Japan, Mexico, New Zealand, RoK, and Singapore. India in 2020 joined the group as a founding member. India occupying the chair also signifies how the world today perceives India as a Trusted Technology partner and one that has always advocated for the ethical use of technology.



Reserve Bank of India launches Digital Rupee



The Reserve Bank of India launched the Digital Rupee, becoming one of the first central banks to introduce a digital currency.

RBI has launched pilots of the Central Bank Digital Currency (CBDC) in both Wholesale and Retail segments. The pilot in wholesale segment, known as the Digital Rupee -Wholesale (e₹-W), was launched on November 1, 2022. Use of (e₹-W), is expected to make the inter-bank market more efficient and settlement in central bank money would reduce transaction costs. The pilot in retail segment, known as digital Rupee-Retail (e₹-R), was launched on December 01, 2022, within a closed user group (CUG) comprising participating customers and merchants. RBI has identified eight banks for phase-wise participation in the retail pilot project. Other steps being taken by RBI for full operationalisation of CBDC include expanding the scope of the pilots gradually to include more banks, and receiving feedback from users and locations during the pilots.





DRDO successfully flight-tests long-range AD-1 interceptor missile

Defence Research & Development Organisation (DRDO) conducted a successful maiden flight-test of Phase-II Ballistic Missile Defence (BMD) interceptor AD-1 missile with large kill altitude bracket from APJ Abdul Kalam Island off the coast of Odisha on 2 November 2022. The flight-test was carried out with participation of all BMD weapon system elements located at different geographical locations. The AD-1 is a long-range interceptor missile designed for both low exo-atmospheric and endo-atmospheric interception of long-range ballistic missiles as well as aircraft. It is propelled by a two-stage solid motor and equipped with indigenously-developed advanced control system, navigation and guidance algorithm to precisely guide the vehicle to the target.

3rd edition of the 'Pan-India' Coastal Defence Exercise 'Sea Vigil-22'




The 3rd edition of the 'Pan-India' Coastal Defence Exercise 'Sea Vigil-22' was conducted on 15-16 November 2022. This National Level Coastal Defence Exercise was conceptualized in 2018 to validate various measures that have been instituted toward enhancing maritime security. Coastal Security being a major sub-set of Coastal Defence construct, the concept of 'Sea Vigil' is to activate the Coastal Security apparatus across India and assess the overarching Coastal Defence mechanism.

The exercise is a build up towards the major Theatre Level Readiness Operational Exercise (TROPEX), which the Indian Navy conducts every two years. Sea Vigil and TROPEX together will cover the entire spectrum Maritime Security challenges.

While smaller scale exercises are conducted in Coastal States regularly, including combined exercises amongst adjoining states, the conduct of exercise Sea Vigil at the national level is aimed to serve a larger purpose. It provides opportunity, at the apex level, to assess India's preparedness in the domain of Maritime Security and Coastal Defence.

INDIA'S GROWTH STORY

India's agricultural and processed food product exports up by 25%



Exports of agricultural and processed food products rose by 25% within six months of the current Financial Year 2022-23 (April-September) in comparison to the corresponding period of FY 2021-22, according to the provisional data released by the Directorate General of Commercial Intelligence and Statistics (DGCI&S).

The overall export of Agricultural and Processed Food Export Development Authority (APEDA) products increased to USD 13771 million in April-September 2022 from USD 11056 million over the same period of the last fiscal year.

The initiatives taken by the Ministry of Commerce and Industry through APEDA have helped the country achieve 58% of its total export target for the year 2022-23 within six months of the current fiscal.
