On behalf of the Vietnam Electricity, Vinh Tan 4 Thermal Power Plant (EVNTPP VINH TAN 4) is inviting bidders to submit bids for the Package TH2024-VT01: Procurement of imported coal for commercial operation of Vinh Tan 4 Thermal Power Plant during 2024-2025.
